

EU Experts Call for Expression of Interest 2021-2027

Role of Experts

- To assist the EU services **in a personal capacity** as experts with the implementation of EU funding and tenders managed through the Funding & Tenders Portal, in particular:
 - **assessing applications** for funding;
 - **monitoring** of projects and contracts;
 - providing **opinions and advice** on specific issues.
- Tasks may include evaluation, monitoring and advice of all types (such as evaluation of applications, observing evaluation procedures, project reviews, coaching activities, ethics reviews including checks and audits).

EU Experts Call for Expression of Interest 2021-2027

Selection Rules

- Selection of experts is made (as and when needed) from the Database, on the basis of selection criteria such as:
 - professional expertise and experience,
 - language skills (English in particular),
 - geographical diversity,
 - business-sector balance,
 - gender balance (target of 40% of the under-represented sex),
 - regular rotation (target of 25% of newcomers), and
 - absence of conflict of interest.

If you are selected, you will sign a **contract** with the Commission with the details relating to your assignment (e.g. tasks and working arrangements, remuneration and payment arrangements).

- **Evaluation** of proposals, prize applications and tenders
- **Monitoring** of actions, grant agreements, public procurement contracts

In addition, experts provide opinion and advise on:

- **Preparation, implementation and evaluation of EU programmes and design of policies.**

In order to select experts, the European Union Institutions publish regularly calls for expression of interest (see list below) detailing the selection criteria, the required expertise, the description of the tasks, their duration and the conditions of remuneration.

Who can see my profile

Institutions I agree to work with:

- EU institutions and bodies
- Other EU Institutions (European Parliament, European Council, Court of Justice of the European Union, European Central Bank, European Investment Bank, European Court of Auditors, European Committee of the Regions, European Economic and Social Committee, ...)

1. An 'adequacy decision' recognises that a third country offers data protection standards equivalent to the ones in the EU/EEA countries. In principle, the transfer of personal data to non-adequate third countries is much more risky compared to EU/EEA countries and adequate third countries. Therefore, given the risks, in the absence of an 'adequacy decision', your data may be transferred to a third country if you have provided your explicit consent.

- All programmes and sub-programmes of the above selected EU and non-EU institutions.

If you are contacted for tasks that are beyond your competences, you can always decline to work on these tasks with no further consequences.
